This Order is made by the Council of the Borough of South Tyneside under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement (Third Review) of Public Rights of Way Prepared by the County Council of Durham Under the National Parks and Access to the Countryside Act 1949 Relating to the (Former) Urban District of Boldon require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) namely, that a right of way not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The South Tyneside Council hereby order that:

1. For the purpose of this order the relevant date is 1<sup>st</sup> November 2010.
2. The Definitive Map and Statement (Third Review) of Public Rights of Way Prepared by the County Council of Durham Under the National Parks and Access to the Countryside Act 1949 Relating to the (Former) Urban District of Boldon shall be modified as described in Part I and Part II of the schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as The South Tyneside Council Public Footpath, Boldon No. B61 (Tracey Avenue to New Road) Definitive Map Modification Order 2010.

## SCHEDULE

### PART I

#### **Modification of Definitive Map**

Description of path or way to be Added (A-B-C-D-E-F-G-H)

Footpath commencing between 35 Tracey Avenue and 37 Tracey Avenue at Grid Reference NZ 3566, 6167 (Point A) and proceeding in a generally northerly direction for approximately 25 metres to Grid Reference NZ 3565, 6169 (Point B). From Grid Reference NZ 3565, 6169 (Point B) the public footpath proceeds to the bridge at Grid Reference NZ 3555, 6170 (Point C) in a westerly direction for approximately 98 metres. The public footpath then proceeds in a generally north westerly direction for approximately 113 metres to Grid Reference NZ 3546, 6177 (Point D) where the public footpath proceeds in a westerly direction for approximately 25 metres to Grid Reference NZ 3544, 6177 (Point E). From Grid Reference NZ 3544, 6177 (Point E) the public footpath proceeds in a northerly direction for approximately 53 metres to Grid Reference NZ 3543, 6182 (Point F). The public footpath then proceeds in a generally westerly direction between Boldon School and Boldon Community Centre for approximately 92 metres to Grid Reference NZ 3542 6181 (Point G). From Grid Reference NZ 3542 6181 (Point G) the public footpath proceeds in a generally northerly direction for approximately 70 metres to New Road at Grid Reference NZ 3533, 6188 (Point H).

### PART II

#### **Modification of Definitive Statement**

Footpath commencing between 35 Tracey Avenue and 37 Tracey Avenue at Grid Reference NZ 3566, 6167 and proceeding in a generally northerly direction for approximately 25 metres to Grid Reference NZ 3565, 6169. From Grid Reference NZ 3565, 6169 the public footpath proceeds to the bridge at Grid Reference NZ 3555, 6170 in a westerly direction for approximately 98 metres. The public footpath then proceeds in a generally north westerly direction for approximately 113 metres to Grid Reference NZ 3546, 6177 where the public footpath proceeds in a westerly direction for approximately 25 metres to Grid Reference NZ 3544, 6177. From Grid Reference NZ 3544, 6177 the public footpath proceeds in a northerly direction for approximately 53 metres to Grid Reference NZ 3543, 6182. The public footpath then proceeds in a generally westerly direction between Boldon School and Boldon Community Centre for approximately 92 metres to Grid Reference NZ 3542 6181. From Grid Reference NZ 3542 6181 the public footpath proceeds in a generally northerly direction for approximately 70 metres to New Road at Grid Reference NZ 3533, 6188.

#### **Width of the Path**

Grid References NZ 3566, 6167 (Point A) to NZ 3565, 6169 (Point B) 3.0 meters.  
Grid References NZ 3565, 6169 (Point B) to NZ 3546, 6177 (Point D) 1.5 meters.  
Grid References NZ 3546, 6177 (Point D) to NZ 3533, 6188 (Point H) 5.0 meters.

#### **Surface of the Path**

Grid References NZ 3566, 6167 (Point A) to NZ 3533, 6188 (Point H) tarmac.
