# Electoral Registration and Administration Act 2013 Notice of Review of Polling Districts, Places and Stations

Notice is hereby given that South Tyneside Council is to carry out a review of the existing polling districts, places and stations in the Borough.

In accordance with the provisions of the Representation of the People Act 1983 and The Electoral Registration and Administration Act 2013, every five years the Council must undertake a review of the polling districts and polling places within its area. The next review must take place in the period of 16 months from 1st October 2023.

The review will begin on 9 October 2023 and will be completed at a meeting of Full Council on 18 January 2024. Ward boundaries are **NOT** included in this review.

If changes are made to the polling district boundaries, as a result of the review, a revised register of electors will be published on 1 March 2024.

The aim of the review is to ensure that:

- (i) all electors have reasonable and practicable facilities for voting, and
- (ii) as far as is reasonable and practicable, polling stations are accessible to all electors, including those who are disabled.

Representations will be sought from the Acting Returning Officer for the existing Parliamentary constituencies of Jarrow and South Shields, a copy of which will has been published on our website.

Representation will also be sought from ward councillors, MPs, and candidates and election agents at the recent elections.

The Council also welcomes comments from residents, particularly disabled residents, and any person or body with expertise in access for persons with any type of disability.

Those making representations should, if possible, give alternative places that may be used as polling places.

Comments or suggestions should be made in writing to the Elections Team, South Tyneside Council, Town Hall, Westoe Road, South Shields, NE33 2RL, or by email to <a href="mailto:elections@southtyneside.gov.uk">elections@southtyneside.gov.uk</a> by **Friday 3 November 2023**.

Details of representations received will be published as part of the review process.

As a result of the recent Boundary Commission for England (BCE) review, the parliamentary constituencies are changing. As part of this review the council with take into the consideration the BCE changes, and the need to hold a UK Parliamentary General Election before 28 January 2025, to ensure that elections can be delivered successfully and that voting facilities are convenient and accessible for electors. ## Review of polling districts, polling places and polling stations

### **Introduction**

In accordance with the Electoral Administration Act 2006 and the Electoral Registration and Administration Act 2013 the Council is carrying out a review of polling districts, polling places and polling stations.

This note sets out background information on this review.

### **Legal Requirements**

### **Polling districts**

For **Parliamentary** elections South Tyneside Council, like other metropolitan boroughs, must divide its parliamentary constituencies into polling districts. It must also keep the polling districts under review.

The existing Parliamentary constituencies of Jarrow and South Shields are situated wholly or partly within the Council's area

For **local** elections, the Council may divide its wards into polling districts, and in practice does so. Polling districts for local government elections should reflect as closely as possible those used for Parliamentary elections.

### **Polling places**

The Council must have a polling place for every polling district in the constituency. The polling place is the geographical area in which the polling station is located (for example, a polling place could be a school building, while the polling station is the actual room within which voting takes place).

### **Polling stations**

The Returning Officer for the election in question must provide a sufficient number of polling stations and allocate electors to polling stations in such a way as he/she thinks most convenient. The polling station must be within the designated polling place.

In practice, there is a close link between polling districts, polling places and polling stations. As there is little point in designating polling districts that have no suitable polling places, the availability of a suitable polling place will be an important factor in considering the designation of polling districts.

### **The Review**

The review process is laid down by law and can be summarised as follows:

- the Council must publish notice of the review,
- the Council must consult the Acting Returning Officer for every parliamentary constituency in its area. It must also consult people with expertise in relation to access to premises or facilities for persons with different forms of disability,
- any elector in the Council's area may make representations,
- the Council considers all representations received and reaches final decisions on the designation of polling districts and polling places,
- the Council publishes its decisions, with reasons, plus all prescribed information (copies of correspondence, representations, minutes of meetings etc).

In carrying out the review, the Council must:

- seek to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances,
- seek to ensure that so far as is reasonable and practicable, polling places are accessible
  to all electors, including those who are disabled. When considering the designation of a
  polling place, the Council must have regard to the accessibility needs of disabled
  persons.

In addition, the polling place for a polling district must be within the area of the district unless special circumstances make it desirable to designate an area outside of the polling district.

### **Background information**

The Council currently has 68 designated polling places and 80 polling stations.

Six places are portable units (port-a-cabins), ten places host 2 polling stations, one place hosts 3 polling stations.

The regulations governing the review refer to 'such **reasonable** facilities for voting as are **practicable** in the circumstances'.

In considering what is reasonable and practicable it is important to take account of both the cost and the impact on the management of elections.

As far as cost is concerned, portable units used as polling stations are the most expensive option, they are also a poor facility for voters, especially those with disabilities.

The management of elections is increasingly complex, largely as a consequence of the changes introduced by the Elections Act 2022; voter identification, accessibility and changes to rules around voters handing in postal votes at a polling station.

### Practical considerations when designating polling places

### Accessibility

All polling stations should have access facilities for disabled electors. This includes wheelchair users.

A polling station should be within reasonable walking distance for most electors.

In addition to any accessibility requirements already set out in other relevant legislation, The Elections Act introduced a duty for (Acting) Returning Officers to take all reasonable steps to provide equipment to support disabled voters to vote independently and in secret at the polling station, and in doing so, to have regard to any relevant guidance issued by the Electoral Commission.

The Council's Building Surveyor, with special responsibility for the Disability Discrimination Act, will be asked to advise on the accessibility needs of disabled persons in relation to the designation of polling places.

### **Availability**

Whilst regulations permit the Returning Officer to use schools and publicly funded buildings, other buildings such as church halls, sports clubs etc. are not obliged to make their building available for use.

### Suitability

When selecting a polling place there are some basic criteria which need to be considered:

- Location is it central for the majority of the electorate?
- Access is the building accessible for all voters including those with a disability?
- Space is there a large enough room to use as a polling station? Could it accommodate two polling stations at a parliamentary election if required?
- Other users will the building be used by others during the day?
- Facilities does the building have welfare facilities for staff?

### **Use of Schools**

The Returning Officer will only use a school as a polling station where there is no suitable alternative. Where schools are used the decision whether to close or remain open lies with the school itself.

### Timetable for the review and how to have your say

The Council is seeking representations by **Friday 3 November 2023**. It will seek comments on those representations from people with disability expertise.

The Council is required to publish all representations made in connection with the review, including the representations of the Acting Returning Officer.

All representations received will be considered and final proposals will be prepared. It is intended that these proposals will be agreed at the Council meeting on 18 January 2024.
